Message from the FOUNDER



As we reflect on the past year, we look back at how far we have come - from contributing to the mid-term review of the India New Born Action Plan to accelerate the elimination of preventable newborn deaths and still births to synthesizing information about the current healthcare challenges and needs in various thematic areas such as cyberbullying, emergency health preparedness, neglected tropical diseases (NTDs) and environmental surveillance etc. In June 2021, we established three-year partnership Association of Preventive and Social Medicine (IAPSM) to accelerate joint efforts in public health research, policy implementation and community outreach with a commitment to promoting and building people-centric, resilient, and sustainable health systems.

We are filled with immense gratitude for the continued support and dedication of our team and partners in advancing our mission to strengthen primary health services that promote equitable, quality and accessible healthcare for all. Our team has worked tirelessly to develop innovative and effective solutions, backed by rigorous research and technical expertise to create sustainable change in the public health landscape.

The COVID-19 pandemic has underscored the importance of strong primary healthcare services and it has shown us how science and tech-led innovations have a great potential in strengthening primary healthcare and taking health services to the last mile. At FPHS, we are committed to leveraging data and tech-led innovations to achieve this goal.

To this end, we have launched a community-based initiative for healthy schools through a community-based approach and engagement with the local elected leaders. This is based upon the principle of 3Ps - Promoting health, Preventing diseases, and Prompt treatment. We intervene at various stages for school health and mental health of the students to ensure their well-being. By the end of 2023, FPHS aims to reach 4000 children across government and private sectors through community participation and at low-cost.

During the year, we contributed to building capacities of early public health professionals through our internship and fellowship program. The FPHS Fellowship program launched in 2022 provided diverse training opportunities to 35+ cohort of PH students and professionals to learn, understand and contribute to new health initiatives.

FPHS also pioneered in paperless mobile device-based field data collection and effectively used the approach for the collection of bottleneck analysis data for midterm review of India New Born Action plan. This was an endto-end paperless exercise. In the year ahead, this would be expanded to additional areas and data collection processes.

In addition, FPHS has also utilized photography as a tool to communicate complex health issues at national and international levels and as an advocacy tool across all sectors for social and behavioral change. We have simplified technicalities into visual and easyto-understand textual content for multiple stakeholders for better performance of planned and existing health interventions. In a first-ofits-kind initiative, we have created a platform to bring together photographers, visual artists, journalists, public health experts and students to provide space for interdisciplinary conversation to enable knowledge exchange and learning, and mentored project development at the intersection of photography, art, and public health.

The year ended on a great note as 'The entwined fate of humans and rivers'- a photo project by the FPHS and our visual storytelling initiative We Photo, won the prestigious LANCET Photography competition and published by THE LANCET – the leading medical journal in December 2022 issue- Sharpening the focus on health stories, highlighting that access to safe water, sanitation and hygiene practices remains out of reach for many disadvantaged people across the world.

We owe our success to the unwavering support of our donors, partners, and team members. Your generosity and commitment have been the driving force behind our achievements. As we continue to navigate the challenges of the current healthcare landscape, we are confident that together, we can create a brighter, healthier future for all.

Policy and strategy work

FPHS supports mid-term review of India Newborn Action Plan

FPHS played a significant role in supporting the Government of India and UNICEF in undertaking the mid-term review of the India Newborn Action Plan (INAP). FPHS contributed to the Bottleneck Analysis work for the mid-term review of INAP by providing an ODK-based tool

and analyzing the data collected through the process. INAP is an essential area of work for FPHS that focuses on improving neonatal and stillbirth rates in India with a goal of achieving a single-digit mortality rate by 2030.

While the last eight years have been eventful, with renewed commitments on various policy fronts, including the National Health Mission and the launch of Ayushman Bharat program, the COVID-19 pandemic disrupted progress. However, with the global renewal of

Safe Birth: A Call to Action



Safe Birth Report: Ensuring Safe and Healthy Pregnancies

FPHS took the lead in drafting the Safe Birth Report, which focuses on maternal health in India and explores a life course approach to maternal health. The report also covers topics such as maternal health policies, empowering communities through grassroots strategies, and maternal healthcare in India - challenges to action.

The goal of the project was to accelerate the efforts towards ensuring safe and healthy pregnancies for newborns and children. The report was released at a high-level event held at the Embassy of Switzerland on 13 September 2022 and attended by approximately 50 experts. The drafting of the report was led by the FPHS team with support from Human Capital Lighthouse Consulting Pvt Ltd, and a national advisory board was formed with the participation of leading Indian experts from around 20 organizations.

The Safe Birth Report was endorsed by eight organizations, including The Federation of Obstetric and Gynaecological Societies of India, Indian Association of Preventive and

Social Medicine (IAPSM), Jhpiego India, Population Council Institute (PCI), Save the Children, India, and Foundation for Mother and Child Health India.

Understanding of Monkeypox Outbreak in India

When the Monkeypox outbreak emerged, the FPHS team took action by publishing opinion pieces on the topic and India's first review article in a peer-reviewed medical journal XXXXX. The review article provides a comprehensive overview of the outbreak in India, including its epidemiology, clinical presentation, diagnosis, and management. The article aims to increase awareness and understanding of Monkeypox among healthcare providers and the general public.


In addition to the review article, the FPHS team published opinion pieces on the topic that got published in XXXXXX, which offered insights into the outbreak and its implications for public health in India. These opinion pieces provide valuable perspectives on the outbreak from experts in the field and highlight the need for preparedness and response to emerging infectious diseases in India.

Prioritizing the importance of healthy diet and nutrition

FPHS contributed to a report on Front-of-Pack Labelling on Unhealthy Food and Beverages to prioritize the importance of health diet and nutrition in the young population.

FPHS Collaborates with Maulana Azad Medical College to Address Cyberbullying and Digital Safety among Youth in India

FPHS provided technical expertise to Maulana Azad Medical College to address the growing issue of cyberbullying and digital safety



"Cyberbullying and Digital Safety - Applying Global Research to Youth in India," highlights the impact of cyberbullying on youth's mental, socio-economic, psychological, and physical health. The book advocates for a holistic approach to address the issue and provides recommendations for parents, educators, healthcare providers, and policymakers.

The collaboration between FPHS and Maulana Azad Medical College aims to raise awareness about cyberbullying and promote digital safety among youth in India. The book draws on global research to provide insights into the issue and offers practical solutions to prevent and address cyberbullying. By taking a comprehensive approach, the book encourages stakeholders to work together to promote a safe and healthy online environment for youth in India.

Community interventions and outreach to promote public health

Community interventions and outreach

activities play a crucial role in promoting public health. Through its community outreach activities, FPHS educate and engage individuals, families, and communities in behaviors and practices that promote healthy lifestyles and prevent diseases and injuries. During the year, FPHS partnered with various stakeholders to work provide health education and promotion to individuals and communities, such as information on disease prevention, regular health checkups, hygiene practices, health screening and immunization to prevent and control the spread of diseases.

Reaching the unreached: an awareness campaign on Hepatitis B

FPHS took a step towards bringing Hepatitis care closer to the community and organized an awareness campaign among the waste collectors of New Seemapuri, Delhi, on the occasion of the World Hepatitis Day 2022, in collaboration with the Indian Pollution Control Association (IPCA). The campaign focused on creating awareness about the need for Hepatitis B vaccination and its preventive measures among the rag pickers, who are at a higher risk of health conditions due to poverty and the unsafe working environment.

Donate Blood. Save Lives

FPHS organized a blood donation camp to observe the World Blood Donors Day in



collaboration with Organum Donum. The initiative garnered support from our partner UNICEF India and the local councilor of Mehrauli, Delhi. The blood donation drive was successful in encouraging people to donate blood. Community participation has an incredible potential to drive social and behavior change for better health outcomes.

FPHS creates awareness about waste management in the urban slums in Delhi

FPHS is committed to creating a healthier and cleaner environment for all. On the occasion of World Health Day 2022, FPHS interns took the initiative to survey and interact with people about waste management in one of the urban slums in the outskirts of Delhi. The survey aimed to understand the community's practices and knowledge about waste management. It included questions such as whether people segregate their waste and why they do it, and whether they keep their surrounding areas clean.

The survey revealed that the community had good knowledge about waste management and were already segregating their waste at home into different bins. FPHS is proud to have played a small part in this important initiative and will continue to motivate and encourage the community to practice proper waste

management and keep their surroundings clean.

FPHS takes the lead in using visual storytelling for Public Health Advocacy

Co-organized by We Photo and the Foundation for People-centric Health Systems (FPHS) in collaboration with PATH, this workshop brought together a diverse group of over 30 participants, including public health experts, communication and media professionals, film makers, photographers, and public health students. The goal of the workshop was to explore the intersection of visual communication and public health and discuss how visual storytelling can drive change and raise awareness about health issues.

This initiative represents our first step towards creating a platform for interdisciplinary knowledge exchange and mentored photography and film projects development to tell compelling stories and provide a voice to communities in telling their own stories. Our first series, focused on public health, aims to visually capture the commercial and social determinants of health (CSDH) and their impact on the health of individuals, communities, and populations. CSDH has long been overlooked, and we hope to use socialimpact photography to help reframe the way



we relate to public health and its underlying determinants.

Through this initiative, going forward we seek to 'show and tell' complex ideas and provide clarity on the social determinants of health. We want to create a new narrative around these issues and encourage emerging talent to embrace visual storytelling with a social impact lens. We believe that this initiative is a significant step towards making a real impact on public health.

Countering misinformation through advocacy and outreach

FPHS actively involved in the fight against the infodemic by disseminating accurate and reliable information to the public. Through its extensive network, FPHS published over

150 opinion pieces, editorials, and columns in newspapers, reaching a wide audience with its message of evidence-based public health. Our experts engaged in over 90 conversations in institutions, providing expert guidance on how to navigate the complex landscape of health information. In additional, FPHS featured in over 60 mass media channels for advocacy amplifying its message to an even larger audience. By actively working to combat the infodemic, FPHS is helping to ensure that accurate health information is accessible to all, promoting the health and well-being of individuals and communities worldwide.

Nurturing Talent, Strengthening Public Health: FPHS's Capacity Building Efforts

Capacity building is an essential aspect of



FPHS's work to improve the public health landscape in India. The organization has launched several initiatives that focus on building the skills and knowledge of young professionals in the public health field. FPHS organized the World Hepatitis Day essay competition during the month of July, 2022, to engage with social work and public health students, and provided guidance and

mentorship to the participants and helped in building their research and writing capacities.

Through the Public Health Internship Program, FPHS provided young minds with a platform to implement their new ideas on the ground as well as while conducting research at their desks. This internship enabled them to gain practical experience, build networks, and

bring a fresh perspective to the field of public health. During the year, a cohort of 14 interns worked with FPHS across areas of public health research, advocacy, data collation, knowledge management and community engagement initiatives.

The Public Health Research Fellowship (PHRF) is a flagship program of FPHS aimed at building the capacity of young public health professionals. During the year, the fellowship provided a learning opportunity for a cohort of 35 individuals to exchange academic and practical knowledge with

each other to promote bi-lateral learning. Throughout the six-month program, fellows conducted primary and secondary research to submit reports/papers on various topics related to public health such as Monkey-pox disease, Hepatitis, COVID-19 etc.. Experts in public health, community medicine, science and development communications, public health policy-making, and interdisciplinary research backgrounds provided guidance and mentorship to enhance the research abilities of fellows. This program is a testament to FPHS's commitment to capacity-building and improving the public health landscape in India.



About the Fellowship

The FPHS Public Health (Research) fellowship is a learning opportunity of six months which aims to build the capacity of the public health professionals. Each fellow gets two projects where they will carry the primary and secondary research to submit reports/papers on recommendations and gaps. Throughout the fellowship program several experts are

sharing the guidance and mentoring the individuals to enhance the research abilities of fellows.

The WHO competencies model was used to design the fellowship where the core components align with the overall capacity building and research skills development of the individuals. The format of the engagement ranges from encouraging the mandatory skills such as technical expertise, work



attitude, teamwork to building leadership qualities, networking and synergised working styles. The management skills and the core competencies in an individual will lead to growth in professional aspects of the life as well as the personal.

Scope of Engagement

- Work on background papers, reports, and policy briefs- The fellows are expected to study on assigned topics related to public health. The learning reports should be shared with the FPHS team regularly.
- Publish journal articles and prepare project or research reports- Fellows are expected to submit a minimum of two journal articles during the fellowship.
- Execution of national level research conference- Fellows with the help and guidance of FPHS team will support in execution and implementation of a national public health forum and conference. The event will be for four days in New Delhi. The individual's cost of travel, accommodation and miscellaneous cost will be covered by the fellow.

 Assist in developing communication collaterals to aware people about FPHS's research works- Willingness to learn social media skills to effectively communicate the undertakings of the office.

IAPSM

We are developing a joint action plan that includes activities such as health education and awareness campaigns, capacity building and training programs for health professionals, and research and evaluation studies.

With the support of Health edvisors and experts on our boards, the plan will be implemented. Health education sessions in schools, training of teachers and health professionals on best practices for school health, and research will be conducted to better understand the health needs of school children.

And we envision that overtime, children will be more engaged in their health and well-being, and health professionals will be better equipped to provide the care and support they need. Mental health services will be more accessible, and children will be receiving the care they need to thrive.

As the partnership will continue to grow and evolve, the impact will spread beyond the region. Other organizations and stakeholders would also be inspired to take action in their own communities.

And so, the story of this partnership continues, as we work together to build a healthier, more resilient community for all.".
